



ADDENDUM TO SRI SAI PAVAN EDUCATIONAL TRUST

THIS ADDENDUM is made and executed on this 10th day of December -2024 at Gangavathi by **SRI SAI PAVAN EDUCATIONAL TRUST, GANGAVATHI** represented by its Presidenent Chairman/Trustee **Sri N.Suribabu S/o Venkatarao**, Aged about 54 years R/o Waddarhatti village Tq: Gangavathi (Adhaar Card No.221375411003) Witnesseth and **Smt. Leelarani Nekkanti W/o Nekkanti Suribabu**, Age: 41 years R/o Waddarhatti village Tq: Gangavathi (Aadhaar Card No.644464153876) as under:

WHEREAS a trust deed was registered on 9.12.2004 in the name of SRI SAI PAVAN EDUCATIONAL TRUST, GANGAVATHI vide registered **document No. BK-IV-30/2004-05** (registered in CD No.GVTD15) by Smt. D.Bujjamma W/o D.Ramu R/o Jeeralkalgudi Camp Tq: Gangavathi and D.Ramu S/o D.Venkateshwararao R/o Jeeralkalgudi Camp, Tq: Gangavathi. Subsequently by way of a registered addendum vide **document No. BK-IV-4/2006-07** dt.13.06.2006, the above Smt.D.Bujjamma and D.Ramu inducted N.Suribabu S/o Venkatarao odderhatti, Ch.Nageshwararao S/o Bullabbai of Sriramanagar, K.Satyanarayana S/o Ganniraju of Anjuri Camp and M.Satyanarayana S/o Suryarao of Dangeri Camp for the better management of the trust.

WHEREAS by way of an another registered rectification deed and addendum, some necessary clauses have been included and also one Sri Donepudi Lokeshwararao S/o Radhakrishnamurthy of Sriramanagar Tq; Gangavathi, H.Suresh S/o H.Vijayakumar R/o Gangavathi and N.Satyanarayana S/o N.Ramarao were admitted as the trustees to the above trust. Subsequently by way of a registered Rectification / addendum deed vide **document No. BK-IV-00051/2009-10** dt.28-10-2009, Donepudi Lokeshwararao, H.Suresh, Ch.Nageshwararao and M.Satyanarayana have put their papers in and submitted their resignation to the Chairman of the Trust, the same was being accepted by the Chairman.

In this regard an addendum was reduced into writing **vide document No.BK-IV-142/2017-18 dt.30.10.2017** wherein Ch. Nageshwararao S/o Bullabai, Donepudi Lokeshwararao S/o Radhakrishnamurthy, H.Suresh S/o Vijayakumar and M.Satyanarayana S/o Suryarao were removed and one **Kumari Akhila Nekkanti D/o N.Suribabu** was inducted into the trust with the existing trustees i.e. the Chairman N.Suribabu and K.Sathyanarayana S/o Ganniraju and N.Satyanarayana S/o N.Ramarao.

WHEREAS now K.Satyanarayana S/o Ganniraju Aged about 48 years R/o Anjuri Camp Tq: Gangavathi and N.Satyanarayana S/o N.Ramarao Aged about 48 years R/o Kotaiah Camp Tq: Gangavathi (Hereinafter called the outgoing trustees) declaring that they have no any rights, interest in the trust or the trust properties expressed their desire leave the trust and the remaining Trustees (**vide document No.BK-IV-14/2018-19 dt.27.04.2018**) i.e. the Chairman **Nekkanti Suribabu** and **Kumari Nekkanti Akhila** have inducted Smt. Leelarani Nekkanti W/o Nekkanti Suribabu Age: 41 years (Aadhaar Card No.644464153876) as the trustee. In that regard a resolution has been passed on 15.04.2018. The continuing trustee Nekkanti Akhila had authorized the Chairman of the trust along with the incoming Trustee Smt. Leelarani Nekkanti to reduce that addendum and in this regard another resolution was passed on 18.04.2018.

WHEREAS apart from the by oversight the following material clauses have been left out in the aforesaid trust deed. Therefore the Chairman/President of the Trust being authorized by the Trust is executing this addendum to including the following clauses after the item No.22 at page No.7 of the original trust deed as.

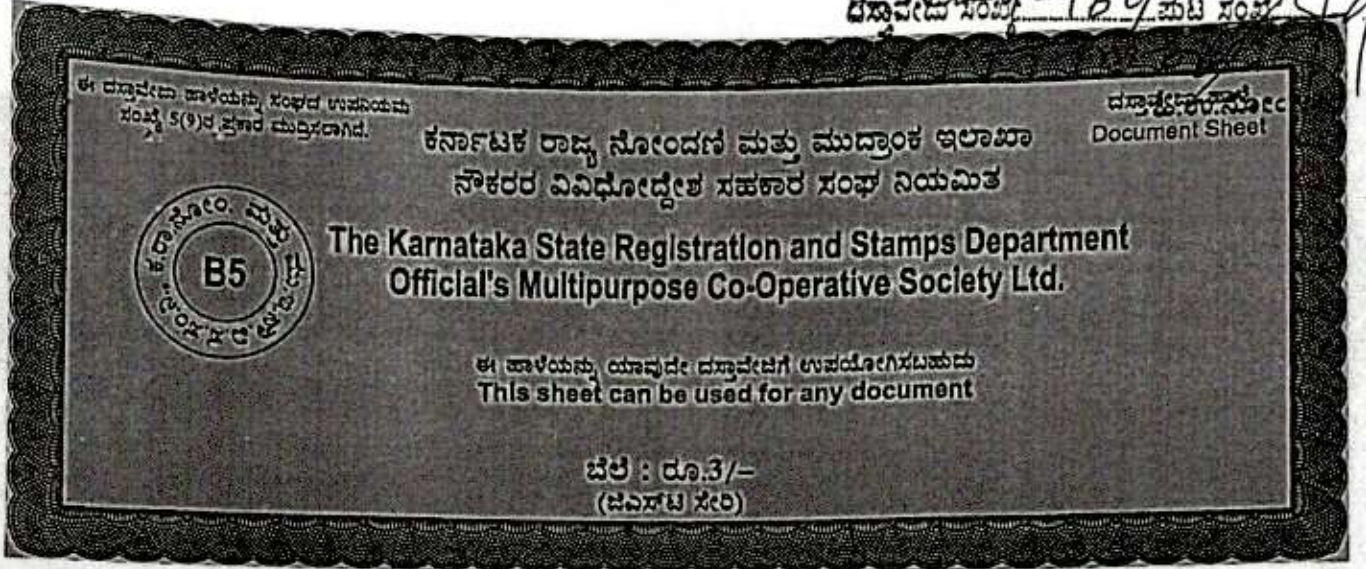
23. DISSOLUTION CLAUSE: In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees of the Managing Committee/Government body but the same shall be transferred to another charitable trust/society whose objects are similar to those of this trust and which enjoys recognition u/s 80G of the Income Tax Act, 1961 as amended from time to time.

24. IRREVOCABILITY CLAUSE: The trust formed shall be irrevocable.

25. BENEFICIARY CLAUSE: The benefits of the Trust shall be open to all irrespective of caste, creed or religion.

26. The funds and the income of the Trust shall be solely utilized for the achievement of objects of the Trust and no portion of it shall be utilized for payment to the trustees byway of profit, interest, commission, dividend etc.

The aforesaid facts with relating to the original regd., trust deed are rectified and made regd., modified trust deed bearing No. 1) BK-4-00004/2006-07, Dated: 13-06-2006. 2) BK-4-00051/2009-10, Dated: 28-10-2009. 3) BK-4-00142/2017-18, Dated: 30-10-2017 and 4) BK-4-00014/2018-19, Dated: 27-04-2018. In this regd., modified trust deed there have been made some rectifications with respect to clauses, even substitution, deletion or addition of new trustees.






